(LSA), the general partner of Special Situations Life Sciences Fund, L.P. (LIFE). AWM serves as the investment adviser to SSFQ and LIFE. (SSF3, SSFQ and LIFE will hereafter be referred to as, the Funds). The principal business of the Funds is to invest in equity and equity-related securities and other securities of any kind or nature.
