On September 13, 2004, First Data Corporation entered into terms agreements (the "Terms Agreements") with Citigroup Global Markets Inc. and the other underwriters named therein, to issue and sell \$450 million of its 3.90% Notes due 2009 and \$550 million of its 4.85% Notes due 2014 in a registered offering.
