The Company revenues for the three months ended, June 30, 2008 as compared to June 30, 2007, increased from approximately \$454,000 to \$908,000 or approximately a 100% increase in revenues. The Company will show a loss for the three months ended, June 30 2008. The increase in revenues is due to an increase in the number of commercial liquidation accounts and revenues generated during the quarter for its majority owned subsidiary, BizAuctions, Inc.

The revenues for the three months ended June 30, 2008 are approximate as the final numbers for the period have not yet been finalized by the Company, and reviewed by its new independent auditors.
