Item 1.01 Entry into a Material Definitive Agreement.

The information required to be disclosed in this Item 1.01 is incorporated herein by reference from Item 3.02.

Item 3.02 Unregistered Sales of Equity Securities.

On October 23, 2006, Callisto Pharmaceuticals, Inc. (the Company) closed a private placement of 105,000 shares of Series A Convertible Preferred Stock (the Series A Preferred Stock) and 1,400,000 warrants (the Warrants) to certain investors (the Investors) for aggregate gross proceeds of \$1,050,000 pursuant to a Securities Purchase Agreement dated as of October 23, 2006 (the SPA). The Warrants are immediately exercisable at \$0.75 per share and are exercisable at any time within five years from the date of issuance. Other than pursuant to certain issuances, for the twelve (12) month period beginning on the effective date of the Registration Statement registering the resale of the shares of Common Stock underlying the Warrants by the Holder, if the Company at any time while the Warrants are outstanding, shall sell or grant any option to purchase or otherwise dispose of or issue any Common Stock or common stock equivalents entitling any Person to acquire shares of Common Stock, at an effective price per share less than the then exercise price (such lower price, the Base Exercise Price , then, the exercise price shall be reduced to an amount equal to the Base Exercise Price.

The Company paid an aggregate \$40,000 and issued an aggregate 53,334 warrants to purchase common stock to certain selling agents. The warrants are immediately exercisable at \$0.75 per share and will expire five years after issuance.

In connection with the offer and sale of securities to the Investors and the selling agents, the Company relied on the exemption from registration provided by Section 4(2) of the Securities Act of 1933, as amended (the Securities Act), and Regulation S and Regulation D promulgated thereunder. The Company believes that the Investors and the selling agents are accredited investors , as such term is defined in Rule 501(a) promulgated under the Securities Act.

The Investors also are parties to a Registration Rights Agreement, dated as of October 23, 2006 (the Registration Rights Agreement), pursuant to which the Company has agreed to file, within 60 days of closing, a registration statement covering the resale of the shares of common stock underlying the Series A Preferred Stock and Warrants issued to the Investors.

Item 5.03 Amendments to Articles of Incorporation or Bylaws; Change in Fiscal Year.

The Company s Certificate of Incorporation have been amended to provide for the issuance of 400,000 shares of Series A Preferred Stock pursuant to the Certificate of Designations, Number, Voting Powers, Preferences and Rights of Series A Convertible Preferred Stock filed with the State of Delaware on October 24, 2006, which provides that:

<u>Voting Rights.</u> Except as otherwise provided herein and as otherwise required by law, the Series A Preferred Stock shall have no voting rights. However, so long as any shares of Series A Preferred Stock are outstanding, the Company shall not, without the affirmative vote of the Holders of the shares of the Series A Preferred Stock then outstanding, (a) alter or change adversely the powers, preferences or rights given to the Series A Preferred Stock or alter or amend the Certificate of Designation (whether by merger, consolidation or otherwise), (b) authorize or create any class of stock ranking as to dividends, redemption or distribution of assets upon a Liquidation senior to or otherwise pari passu with the Series A Preferred Stock, (c) amend

its certificate of incorporation or other charter documents (whether by merger, consolidation or otherwise) so as to affect adversely any rights of the Holders, (d) increase the authorized number of shares of Series A Preferred Stock, or (e) enter into any agreement with respect to the foregoing.

Liquidation. Upon any liquidation, dissolution or winding-up of the Company, whether voluntary or involuntary (a Liquidation), the Holders shall be entitled to receive out of the assets of the Company, whether such assets are capital or surplus, for each share of Series A Preferred Stock an amount equal to the Stated Value per share plus any accrued and unpaid dividends thereon and any other fees or liquidated damages owing thereon before any distribution or payment shall be made to the holders of any junior securities, and if the assets of the Company shall be insufficient to pay in full such amounts, then the entire assets to be distributed to the Holders shall be distributed among the Holders ratably in accordance with the respective amounts that would be payable on such shares if all amounts payable thereon were paid in full.

Conversion.

<u>Conversions at Option of Holder</u>. Each share of Series A Preferred Stock shall be convertible into that number of shares of Common Stock determined by dividing the Stated Value of such share of Series A Preferred Stock by \$0.75 (the Conversion Price), at the option of the Holder, at any time and from time to time.

<u>Automatic Conversion</u>. Beginning October 24, 2007, provided certain conditions are satisfied, if the volume weighted average price of the Common Stock equals \$1.50 (subject to adjustment for stock splits, reclassifications, combinations and similar adjustments) per share for the 20 consecutive Trading Days immediately prior to the Automatic Conversion Notice Date (as defined below), and an average of 50,000 shares of Common Stock per day shall have been traded during such 20 Trading Days, unless the Holder is prohibited from converting the Series A Preferred Stock pursuant to certain limitations, the Company shall have the right to deliver a notice to the Holder (an <u>Automatic Conversion Notice</u> and the date such notice is received by the Holder, the <u>Automatic Conversion Notice</u> of the shares of Series A Preferred Stock then held by the Holder into shares of Common Stock at the then-effective Conversion Price.

<u>Subsequent Equity Sales</u>. Other than pursuant to certain issuances, for the twelve (12) month period beginning on the effective date of the Registration Statement registering the resale of the shares of Common Stock underlying the Series A Preferred Stock by the Holder, if the Company at any time while Series A Preferred Stock is outstanding, shall sell or grant any option to purchase or otherwise dispose of or issue any Common Stock or common stock equivalents entitling any Person to acquire shares of Common Stock, at an effective price per share less than the then Conversion Price (such lower price, the <u>Base Conversion Price</u>, as adjusted hereunder (if the holder of the Common Stock or common stock equivalents so issued shall at any time, whether by operation of purchase price adjustments, reset provisions, floating conversion, exercise or exchange prices or otherwise, or due to warrants, options or rights per share which is less than the Conversion Price, such issuance shall be deemed to have occurred for less than the Conversion Price), then, the Conversion Price shall be reduced to an amount equal to the Base Conversion Price.
