As announced on November 14, 2006, Fossil, Inc. (the Company) has formed a committee made up of all independent members of its Board of Directors (the Special Committee) to voluntarily review the Company's equity granting practices. The Special Committee has just recently commenced a search for independent legal counsel to assist in the review. Accordingly, the Company is delaying the filing of its Quarterly Report on Form 10-Q for the quarter ended October 7, 2006 (the Form 10-Q) until after the Special Committee completes such review. The Company does not currently expect that it will in a position to file the Form 10-Q on or before the fifth calendar day following the required filing date as prescribed by Rule 12b-25.

There can be no assurance that the Company will not have to restate its prior financial statements or adjust certain amounts provided in the press release and during the conference call until after the Special Committee completes its review related to the Company's equity granting practices.

Certain matters discussed in this Notification of Late Filing on Form 12b-25, including those relating to the nature and scope of the Special Committee's pending review, expectations as to the completion of the review and timing of the filing of the quarterly report on Form 10-Q for the period ended October 7, 2006, constitute forward-looking statements.
