**Item 1. Security and Issuer.**

This Amendment No. 11 to Schedule 13D (the Statement ) relates to the Common Stock, no par value per share (the Common Stock ), of Winmark Corporation, a Minnesota corporation (the Company ). The principal executive office of the Company is located at 605 Highway 169 N, Suite 400, Minneapolis, MN 55441.

**Item 2. Identity and Background.**

The Reporting Person may make additional purchases of Common Stock either in the open market or in private transactions, depending on his evaluation of the Company's business, prospects and financial condition, the market for the common stock, other opportunities available to him, general economic conditions, money and stock market conditions and other future developments. Depending on the same factors, the Reporting Person may decide in the future to sell all or part of his investments in the Issuer's Common Stock.

(a) As of the date hereof, the Reporting Person beneficially owns the amount of Common Stock set forth below. The percentage set forth below is based upon 5,125,683 shares of Common Stock outstanding on March 3, 2010.
