On August 16, 2011, the issuer canceled, pursuant to the issuer's option exchange program, an option granted to the reporting person on April 22, 2010 (such canceled option provided for vesting in four equal installments beginning on April 22, 2011). In exchange for the (1) option, the reporting person received 2,064 restricted stock units, 1,032 of which are scheduled to vest on August 16, 2012, 516 of which are scheduled to vest on April 22, 2013 and 516 of which are scheduled to vest on April 22, 2014. Each unit converts into a share of common stock on a one-for-one basis.
