Since you own a substantial number of HEI shares, I wanted to personally reach out to you regarding our merger with NextEra Energy and in particular, the essential role *you* play in charting Hawaii's more affordable clean energy future.

As we announced on May 12, HEI shareholders approved the proposal to extend the deadline for shareholder voting on the proposed merger. Our records indicate that, to date, you have not yet cast your vote. To ensure that our shareholders, customers, employees, communities and the state of Hawaii realize the significant benefits of this combination, HEI is required to obtain a supermajority approval from 75 percent of its outstanding shares. Therefore, unlike other proxy solicitations you may have received in the past, your vote related to our merger is extremely important.

I, along with the entire HEI board of directors, firmly believe that our combination with NextEra Energy represents significant value for your investment and will help Hawaiian Electric accelerate the more affordable clean energy future we all want for Hawaii.

You should have received, or will shortly receive, a package containing your proxy card for voting on the merger. It is critical that you vote FOR the merger today to secure superior value for your shares and help accelerate Hawaii's clean energy transformation.
