Holdco owns 173,335 Subordinate Voting Shares. V. Prem Watsa controls Holdco and Sixty Two and himself owns an additional 85,352 Subordinate Voting Shares and exercises control or direction over an additional 2,148 Subordinate Voting Shares.

Neither the filing of this Schedule 13G nor the information contained herein shall be deemed to constitute an affirmation by V.
