("Empire Capital"), with respect to the 3,039,575 shares, Empire Capital Partners, Ltd. a Cayman Islands exempted company ("Offshore") as to 2,405,289 shares, Charter Oak Partners, LP a Delaware Limited Partnership ("Charter Oak") as to 726,687 shares and Charter Oak Partners II ("Charter Oak II") and collectively with Empire Capital, Offshore and Charter Oak, "the Empire Funds") as to 115,609 shares of Common Stock directly owned by it.
- (1) Empire Capital Management L.L.C. (the "Investment Manager") serves as the Investment Manager and has investment discretion over the securities held by Offshore, Charter Oak and Charter Oak II.
