- (1) in three equal annual installments of 843 each commencing 4/29/2010; and 5,700 RSUs which vests in four equal annual installments of 1,425 each commencing 4/29/2010. Vested RSUs will be paid in shares of the Company's common stock on a one-to-one basis unless payment is otherwise deferred by the reporting person.
