Vested RSUs may be deferred by the director, in which case, payment will occur according to the elected deferral schedule.

DEs are credited on the director's vested but deferred RSUs and are paid out in shares of the Company's common stock on a one-to-one basis along with a cash payment for any remaining fractional share amount.
