## Explanation of Responses:

- (1) The reporting person's holdings include 318,831 shares acquired under the issuer's dividend reinvestment and common stock purchase plan since the reporting person's last report. These shares were acquired pursuant to the employee stock purchase plan provisions of the dividend reinvestment and common stock purchase plan, which acquisitions are exempt from Section 16. Also includes 276,146 shares acquired via dividend reinvestment on July 2 and October 2, 2013 at prices ranging from \$35.94 to \$41.40 per share.
- (2) The number of underlying securities is based on the stock fund balance on September 30, 2013. The actual number of shares issuable upon the distribution date is not determinable since the stock fund is a unitized account consisting of 96% company stock and 4% money market fund. The stock account balance reflected in this report is based on a September 30, 2013, stock fund price of \$41.50 per share.
- (3) Each unit of phantom stock is the economic equivalent of one share of Johnson Controls common stock.

- (4) The phantom stock units accrue under the Johnson Controls Restricted Stock Plan. The balance includes phantom stock and dividend equivalent units that settle 100% in cash and relate to restricted stock awards.
- (5) Includes 365.729 phantom stock units acquired via dividend reinvestment on December 28, 2012, April 2, July 2 and October 2, 2013 at prices ranging from \$31.80 to \$41.47 per phantom stock unit.
