On February 22, 2018 the Issuer granted the Reporting Person a Restricted Stock Award (RSA) of 4,503 restricted shares of First Midwest Bancorp, Inc. Common Stock under the First Midwest Bancorp, Inc. Omnibus Stock and Incentive Plan which were scheduled (1) to vest in three equal annual installments on the first, second and third anniversary of the date of grant. On February 22, 2019, 1,501 of the originally granted RSAs vested, of which 520 shares were surrendered by the Reporting Person in order to satisfy tax withholding obligations. This form is being filed to reflect the surrender of such shares to satisfy the Reporting Person's tax withholding obligation.
