Item 1.01 Entry into a Material Definitive Agreement.

On 3 November, 2008, Southwall Technologies Inc. (the “Company”) entered into Indemnification Agreements with the directors and officers of the Company (each, an “Indemnatee”). Each such Indemnification Agreement provides, among other things, that the Company will indemnify the Indemnatee to the fullest extent permitted by the Delaware General Corporation Law, including advancement of legal fees and other expenses incurred by the Indemnatee in connection with any legal proceedings arising out the Indemnatee's service as director and/or officer, subject to certain exclusions and procedures set forth in the Indemnification Agreement. Each such Indemnification Agreement is identical in all material respects to the Company's form of Indemnification Agreement, attached as Exhibit 10.1 hereto, which is incorporated into this Report in its entirety.
