## Explanation of Responses:

- \* If the form is filed by more than one reporting person, see Instruction 4(b)(v).
  - \*\* Intentional misstatements or omissions of facts constitute Federal Criminal Violations. See 18 U.S.C. 1001 and 15 U.S.C. 78ff(a).
- (1) The holder settled 100 percent of the vested portion of his phantom units previously reported in Table II for RGP common units on the date of vesting.
  - (2) Each Phantom Unit is the economic equivalent of one common unit representing a limited partner interest in Regency Energy Partners LP (RGP).
  - (3) The ending number of securities beneficially owned was reported as 10,000 due to an administrative error; the number should have been 15,000, to include a previously reported 5,000 unit position.
  - (4) The ending number of securities beneficially owned was reported as 7,355 due to the same administrative error described in footnote 3; the number should have been 12,355. This same error was carried forward into the reporting person's Form 4 report filed on December 6, 2011, which should have shown ending total for holdings in Table I of 19,710 RGP common units directly owned.
