Upon vesting of the restricted stock units, the reporting person shall be entitled to receive a number of shares of Class A Common Stock equal to the number of restricted stock units then vesting. The reporting person received the restricted stock unit award under the Clear Channel Outdoor Holdings, Inc. 2012 Stock Incentive Plan.
- In connection with the payment of a special cash dividend of \$6.0832 on March 15, 2012 to Clear Channel Outdoor Holdings, Inc.'s stockholders of record on March 12, 2012, Clear Channel Outdoor Holdings, Inc. made certain anti-dilution adjustments to awards outstanding under Clear Channel Outdoor Holdings, Inc. 2005 Stock Incentive Plan. As a result of the anti-dilution adjustments, the amount of beneficial ownership shown for the reporting person reflects an increase of 3,685 units subject to the reporting person's previously reported restricted stock unit award granted on December 20, 2010. All other terms and conditions governing such award remained unchanged.
