Excess Benefit and Deferred Compensation Plan of 2005 (the "Compensation Plan Trust"), are subject to automatic reinvestment of dividends pursuant to the Issuer's Dividend Reinvestment Plan. On April 19, 2013, July 19, 2013 and October 18, 2013, dividends on these shares were paid and automatically reinvested by the Compensation Plan Trust in additional Class A Common Stock for the benefit of Mr. Myers in the amounts of 12.9191 shares, 13.0299 shares and 14.4804 shares,

- (2) On October 3, 2013, the Compensation Plan Trust purchased 83 shares of Class A Common Stock for the benefit of Mr. Myers at a price of \$19.65 per share.

- Mr. Myers is the direct beneficial owner of 131,950 shares of Class A Common Stock, including the 90,000 restricted shares referenced
- (4) in footnote 3. In addition, he is the indirect beneficial owner of 1,234 shares of Class A Common Stock owned by the Compensation Plan Trust for the benefit of Mr. Myers.
