- (1) Mr. Rusche was awarded 6,644 Restricted Stock Units. Each Restricted Stock Unit represents a contingent right to receive one share of Repligen Corporation's Common Stock. 2,214 Restricted Stock Units vest on 2/27/2015. 2,215 Restricted Stock Units vest on each of 2/27/2016 and 2/27/2017. The Restricted Stock Units may be settled only by delivering shares of Repligen Corporation's Common Stock, and thus, the grant is being reported in Table 1 as allowed per SEC guidance.
- (2) 4,242 shares vest and become exercisable on each of 2/27/2015 and 2/27/2016. 4,243 shares vest and become exercisable on 2/27/2017.
