(1) Since the reporting person's last report, 2,500 shares previously held by Stock Award have vested and are now owned directly.

(5) Stock Options are fully vested and exercisable.

(6) Stock Options granted pursuant to the SI Financial Group, Inc. 2012 Equity Incentive Plan vest in five equal annual installments commencing on October 24, 2013.
