All dollar amounts stated below are approximate.

For the three months ended September 30, 2007, management anticipates that the loss will be \$229,000 as compared to \$816,000 in the corresponding period of the preceding year, a reduction of \$587,000. This reduction was primarily the result having no share based compensation in the current period, as compared to \$460,000 in the preceding year as well as substantial reductions in professional fees.

For the nine months ended September 30, 2007, management anticipates that the loss will be \$906,000 as compared to \$1,544,000 in the corresponding period of the preceding year, a reduction of \$638,000. This reduction was primarily the result having no share based compensation in the current period, as compared to \$500,000 in the preceding year as well as substantial reductions in professional fees.
