BLADEX ANNOUNCES CHANGE TO ONE SEAT ON BOARD OF DIRECTORS

Panama City, Republic of Panama, September 15, 2009 - Banco Latinoamericano de Comercio Exterior, S.A. (Bladex) (NYSE: BLX), announced that Mr. Roberto Feletti has resigned as a Class "A" Director on Bladex's Board after being appointed Deputy Minister of Economy of Argentina. Mr. Feletti was a member of both the Audit and Compliance Committee, as well as the Nomination and Compensation Committee.

Mr. Feletti was replaced by Mr. Carlos Weitz, an advisor to the Presidency of Banco de la Nacion Argentina. Mr. Weitz will serve as a Class "A" Director and member of both the Audit and Compliance and Nomination and Compensation Committees for the remainder of Mr. Feletti's original term, due to expire in April, 2011.
