Item 2.01 Completion of Acquisition or Disposition of Assets.

On January 14, 2015, Synacor, Inc. (Synacor), through a wholly-owned subsidiary, completed the acquisition of certain assets (the "Asset Acquisition") of NimbleTV, LLC (NimbleTV), a New York City-based provider of multiscreen, live linear television programming for pay-TV subscribers. Synacor acquired all of Nimble TV's intellectual property and tangible personal property.
