(1) This stock option previously represented the right to purchase 10,000 shares of the Issuer's common stock at an exercise price of \$13.80. The stock option was converted to the right to purchase 12,101 shares of the Issuer's common stock at an exercise price of \$11.40 effective with the spin-off of the Issuer's specialty chemical business on October 31, 2007. The original option agreement was granted on December 3, 2001 and became fully vested on December 3, 2002.
