





**Item 7.01. Regulation FD Disclosure**

On January 18, 2012, Global Partners LP (the “Partnership”) issued a press release announcing that the Board of Directors of its general partner, Global GP LLC, declared a quarterly cash distribution of \$0.50 per unit (\$2.00 per unit on an annualized basis) on all of its outstanding common units for the period from October 1, 2011 through December 31, 2011. On February 14, 2012, the Partnership will pay such cash distribution to its common unitholders of record as of the close of business February 3, 2012. A copy of the Partnership’s press release is attached hereto as Exhibit 99.1 and incorporated herein by reference.
