Each share of common stock or phantom stock was disposed of in exchange for a cash payment of \$127.50 per share pursuant to the

- (1) Agreement and Plan of Merger by and among United Technologies Corporation, Charlotte Lucas Corporation and Goodrich Corporation dated as of September 21, 2011.
  - (2) Includes 34 shares acquired since the date of the last statement pursuant to the Employee Stock Purchase Plan.
  - (3) The stock option vests in equal annual installments on each of the first three anniversaries of the grant date.
  - (4) This option was canceled in the merger in exchange for a cash payment equal to the difference between \$127.50 and the exercise price per share set forth in Column 2.
  - (5) Restricted Stock Units that vested on the effective date of the merger and were disposed of in exchange for a cash payment equal to \$127.50 per share.
- These shares were deferred under the Goodrich Corporation Performance Share Deferred Compensation Plan, were to be settled in stock
- (6) upon the reporting person's retirement at various times based upon elections made by the reporting person and were disposed of in exchange for a cash payment equal to \$127.50 per share.
  - (7) Each deferred share has the economic equivalent of one share of common stock.
