(1) On May 22, 2014, the Reporting Person was awarded a total of 13,764 restricted shares of Common Stock of iStar Financial Inc. (NYSE:STAR) in accordance with the provisions of the iStar Financial Inc. Non-Employee Directors' Deferral Plan (Plan), which are owned directly. These shares are restricted and may not be sold or otherwise transferred until they vest on May 22, 2105, the one-year anniversary date of iStar's 2014 annual meeting of shareholders.

(2) Following this transaction, the Reporting Person is the beneficial owner of a total of 92,611 shares of Common Stock, of which 43,494 shares are owned directly, 35,977 shares are owned indirectly through revocable trusts and 13,140 shares are owned indirectly by an individual retirement account established by the Reporting Person.

- The Reporting Person also holds a total of 75,513 Common Stock Equivalents (CSEs) awarded pursuant to Plan, all of which are vested. Under the Plan, on the regular distribution date, vested CSEs will be settled by the transfer of shares of iStar Common Stock to the participant. The "regular distribution date" for distributions to Plan participants is the earlier of: (1) January 1 on or next following the
- (3) earlier of (i) the date the participant ceases to be a non-employee director; and (ii) the date of the participant's death; and (2) a change of control (as defined in the Plan). A participant, under certain limited circumstances, is permitted to elect to receive distributions at times other than the regular distribution date.
