- (1) On July 1, 2008, Encore issued 2,828 deferred issuance restricted stock units ("RSUs") to Mr. Oros under the Encore 2005 Stock Incentive Plan in connection with Mr. Oros' service on Encore's board of directors.
- These shares are in the form of RSUs held by Mr. Oros. Each RSU represents the right to receive one share of Encore common stock upon settlement. 3,450 of these RSUs will vest on September 23, 2008. Another 3,450 of these RSUs will vest on August 23, 2009. The remaining 5,652 of these RSUs are fully vested.
