(1) The purchases reported in this Form 4 were effected pursuant to a Rule 10b5-1 trading plan adopted by the reporting person on April 14, 2011.

(2) The price reported in column 4 is a weighted average price. These shares were purchased in multiple transactions at prices ranging from \$1.84 to \$1.90, inclusive. The reporting person undertakes to provide to Patheon Inc., any security holder of Patheon Inc., or the staff of the Securities and Exchange Commission, upon request, full information regarding the number of shares purchased at each separate price within the ranges set forth in footnotes (2) and (3) to this Form 4. The amounts reported in column 4 and this footnote (2) for June 14, 2011 were converted from Canadian dollars into U.S. dollars based on the June 14, 2011 closing exchange rate of 0.9683 Canadian dollars per U.S. dollar as quoted by Reuters.
