## Explanation of Responses:

  - (1) The entities and individuals directly acquiring these shares reported in this filing are SPO Partners II, L.P. ("SPO Partners"), which bought 231,240 shares, San Francisco Partners, L.P. ("SF Partners"), which bought 8,900 shares, John H. Scully ("JHS"), who bought 500 shares, and William E. Oberndorf ("WEO") who bought 2,100 shares. The range of prices for the purchases on 8/25/11, reported in Line 1 above, was \$23.56-24.12 and the range of prices for the purchases on 8/26/11, reported in Line 2 above, was \$24.02-24.05 (full detailed information regarding the shares purchased at each price will be provided upon request).

As a result of the purchases causing this filing, 9,207,149 shares are owned directly by SPO Partners, and may be deemed to be indirectly beneficially owned by (i) SPO Advisory Partners, L.P. ("SPO Advisory"), the sole general partner of SPO Partners, (ii) SPO Advisory Corp. ("SPO Corp."), the sole general partner of SPO Advisory, and (iii) JHS, WEO and Edward H. McDermott ("EHM"), the three controlling persons of SPO Corp. Additionally, 308,800 shares are owned directly by SF Partners, and may be deemed to be indirectly beneficially owned by (i) SF Advisory Partners, L.P. ("SF Advisory"), the sole general partner of SF Partners, (ii) SPO Corp., the sole general partner of SF Advisory, and (iii) JHS, WEO and EHM, the three controlling persons of SPO Corp.
  - (2) Additionally, (i) 15,100 shares are owned by JHS and are held in IRAs, which are self-directed, (ii) 50,800 shares are owned by WEO and are held in an IRA, which is self-directed, and (iii) 1,000 shares are owned by EHM and are held in IRAs, which are self-directed.
