 - (1) 12,000 stock options with an exercise price of \$4.99 were granted on June 14, 2004. These options vest in two installments of 25% each on the first and second anniversary of the grant date, and in eight subsequent quarterly installments of 6.25% each, commencing on September 14, 2006 and ending on June 14, 2008.
 - (2) 44,500 restricted stock units were granted on March 16, 2009. These restricted stock units were performance based, vesting in three tranches based on the achievement of certain annual performance goals of the Company over a three-year period from October 1, 2008 to September 30, 2011. After the assessment for the period from October 1, 2010 to September 30, 2011, on November 3, 2011 the Company determined that the performance goals had been achieved and will allocate the third tranche of PSUs to the employees on November 9, 2011.
