The performance condition will be satisfied on the earlier of (i) March 8, 2014 (which the Issuer may elect to accelerate to February 15, 2014) and (ii) the date of a change in control. Upon the satisfaction of the performance condition, 6.25% of the shares subject to the RSUs vest on each of July 1, 2014, October 1, 2014, January 1, 2015 and April 1, 2015, and 18.75% of the shares subject to the RSUs vest on each of July 1, 2015, October 1, 2015, January 1, 2016 and April 1, 2016.
- (2) Of the reported shares, 582,660 shares are represented by RSUs.
