- (1) Effective upon the consummation of the Issuer's initial public offering of its common stock, par value \$0.01 per share (the "Common Stock"), the Issuer effectuated a distribution, exchange, and stock split. This row reports shares owned immediately following the initial public offering and related transactions.
- (2) The 20,952,262, 6,285,165, and 269,118 shares of Common Stock reported herein are owned directly by Green Equity Investors V, L.P. ("GEI V"), Green Equity Investors Side V, L.P. ("GEI Side V"), and TCS Co-Invest, LLC ("TCS"), respectively. GEI Capital V, LLC ("GEIC") is the general partner of GEI V and GEI Side V. Green V Holdings, LLC ("Holdings") is a limited partner of GEI V and GEI Side V. Jonathan D. Sokoloff is a managing partner of Leonard Green & Partners, L.P. ("LGP"), which is the management company of GEI V and GEI Side V, the manager of TCS, and an affiliate of GEIC and Holdings. LGP Management, Inc. is the general partner of
