The units are restricted, but will vest on an accelerated basis when I retire in May of 2005 as a director of Questar. I will receive a cash payment for the units in June of 2005. I defer my director's fees and these fees are accounted for in phantom stock units, which also are credited with "dividends." The total includes 15,261.9552 phantom stock units under Questar's
