**Mitsui Announces Secondary Offering of Shares in Toho Titanium Co., Ltd.**

Today Toho Titanium Co., Ltd. ( Toho ), an associated company of Mitsui & Co., Ltd. ( Mitsui ) changed its listing position to 1<sup>st</sup> section of the Tokyo Stock Exchange.

Following this transaction, at the request of Toho to diversify its shareholders and to increase market liquidity of its stock, Mitsui has decided to make secondary offering of some portion of its shareholdings in Toho.

1. Number of shares to be offered:

2,300,000 (Common stock)

2. Offering price: to be fixed

3. Number of shares held and voting power before/after this offering:

Before 9,316,226 (15.4%)

After 7,016,226 (11.6%)

This transaction is in line with Mitsui's corporate strategy under the new Medium-term Management Outlook, in which Mitsui has been reviewing and divesting existing investments in parallel with the execution of new investments.

Titanium business will remain unchanged as one of Mitsui's core non-ferrous metal business, in which Mitsui intends to continue to be proactively involved together with Toho after this offering.
