Item 2.01 Completion of an Acquisition or Disposition of Assets

On March 5, 2010, Registrant's wholly-owned subsidiary First-Citizens Bank & Trust Company (FCB) entered into an agreement with the Federal Deposit Insurance Corporation (FDIC) to purchase substantially all the assets and assume the majority of the liabilities of Sun American Bank (Sun American) of Boca Raton, Florida at a discount of \$69.4 million, with no deposit premium. The FDIC serves as Receiver of the institution. The Purchase and Assumption Agreement with the FDIC is attached hereto as Exhibit 2.1. The loans and other real estate purchased by FCB are covered by loss share agreements between the FDIC and FCB which provide protection against losses to FCB. Under the terms of the loss share agreements, the FDIC will reimburse FCB for 80 percent of net losses incurred up to the stated threshold of \$99.0 million, and 95 percent of net losses exceeding the stated threshold.

At December 31, 2009, Sun American reported total assets of \$535.7 million, loans of \$424.1 million and total deposits of \$443.5 million.

Estimates of the anticipated effects of the acquisition on the financial condition, liquidity, capital resources and operating results of FCB will be available after the FDIC provides final information for the assets purchased and liabilities assumed from Sun American. Such estimates will be filed in an amendment to this Report.
