As at 30 April 2012, Prudential s issued share capital consisted of 2,551,677,417 ordinary shares of 5p each and which are admitted to trading. Each ordinary share carries the right to one vote in all circumstances at general meetings of Prudential. Prudential does not hold any Treasury Shares.
