On July 26, 2012, Host Hotels & Resorts, L.P. (Host L.P.), for whom Host Hotels & Resorts, Inc. (Host Inc.) acts as a sole general partner, gave notice that it intends to redeem \$400 million of the \$650 million in aggregate principal amount outstanding of Host L.P. s $\dot{\theta}_8^{\,\prime}$ Series O Senior Notes due 2015. The redemption date for the Series O senior notes is August 27, 2012 pursuant to an irrevocable notice delivered by the trustee on Host L.P. s behalf on July 26, 2012. The Series O senior notes were issued pursuant to a supplement to Host L.P. s Amended and Restated Indenture, dated August 5, 1998, originally among HMH Properties, Inc. (now Host L.P.), the subsidiary guarantors named therein, and HSBC Bank USA f/k/a Marine Midland Bank (now succeeded by The Bank of New York Mellon), as trustee. Under the terms of the Series O senior notes, the redemption price will be 101.063% of the principal amount thereof, together with accrued and unpaid interest thereon to the redemption date.

The Series O senior notes are being redeemed with a portion of the proceeds from the \$500 million credit facility term loan completed by Host L.P. on July 25, 2012.
