On April 23, 2013, Realogy Holdings Corp., a Delaware corporation, issued a press release announcing a private offering by Realogy Group LLC, its indirect, wholly-owned subsidiary and a Delaware limited liability company, of up to \$450,000,000 aggregate principal amount of senior notes due 2016, subject to market and other conditions.
