This Amendment No. 2 to Schedule 13D (this <u>Amendment</u>) amends and supplements the statement of beneficial ownership on Schedule 13D relating to ordinary shares, par value \$0.0001 per share (the <u>Ordinary Shares</u>), of Acquity Group Limited, an exempted company with limited liability incorporated under the laws of the Cayman Islands (<u>Acquity</u>), originally filed with the Securities and Exchange Commission on May 28, 2013 by Accenture Holdings B.V. (<u>Accenture Holdings</u>), a private company with limited liability registered in the Netherlands, and Accenture plc (<u>Accenture</u>), a company organized and existing under the laws of Ireland (collectively, the <u>Reporting Persons</u>) (as previously amended on June 6, 2013, the <u>Schedule 13D</u>). Unless otherwise indicated herein, terms used but not defined in this Amendment have the meaning ascribed to them in the Schedule 13D.

#### Item 3. Source and Amount of Funds

Item 3 of the Schedule 13D is hereby supplemented as follows:

On July 8, 2013, pursuant to the Merger Agreement, the parties to the Merger Agreement consummated the Merger. Each of the Support Agreements terminated at the Effective Time in accordance with its terms.

#### Item 5. Interest in Securities of Issuer

Items 5(a) and 5(b) of the Schedule 13D are hereby amended and restated in their entirety as follows:

As a result of the consummation of the Merger, as of July 8, 2013, the Reporting Persons own all of the Ordinary Shares.
