On August 7, 2013, the Company s Board of Directors approved a quarterly dividend of \$0.21 per share payable on October 1, 2013 to stockholders of record on September 16, 2013. The Board also increased the annual dividend amount from \$0.72 per share to \$0.84 per share. However, the declaration and payment of future dividends to holders of the Company s common stock will be at the discretion of its Board of Directors, and will depend upon many factors, including the Company s financial condition, earnings, capital requirements of its businesses, legal requirements, regulatory constraints, industry practice, and other factors that the Board of Directors deems relevant.
