As at 30 August 2013, Prudential s issued share capital admitted to trading consisted of 2,559,303,390 ordinary shares of 5p each. Each ordinary share carries the right to one vote in all circumstances at general meetings of Prudential. Prudential does not hold any Treasury Shares.
