**Item 5.07 Submission of Matters to a Vote of Security Holders**

On February 4, 2014, PennantPark Investment Corporation (the Company) held its annual meeting of stockholders (the Annual Meeting) and submitted two matters to the vote of stockholders. The proposals are described in detail in the Company's definitive proxy statement filed with the Securities and Exchange Commission on December 5, 2013. As of December 9, 2013, the record date, 66,546,734 shares of common stock were eligible to vote. A summary of the matters voted upon by the stockholders is set forth below.

**Proposal 1.** Due to the absence of the affirmative vote of a majority of the outstanding shares of common stock to elect the nominees, the named Proxies for the Company's stockholders approved an adjournment of the meeting to allow the polls to remain open until 9:30 a.m. on February 25, 2014 for the proposal to elect two Class I directors of the Company, each of whom will serve until the 2017 Annual Meeting, or until his successor is duly elected and qualifies or until his earlier resignation, removal from office, death or incapacity. The meeting will be reconvened at the offices of Dechert LLP, located at 1095 Avenue of the Americas, New York, New York, on February 25, 2014, at 9:30 a.m.

**Proposal 2.** The Company's stockholders ratified the selection of McGladrey LLP to serve as the Company's independent registered public accounting firm for the year ending September 30, 2014. The voting results are set forth below:

On February 4, 2014, the Company held a special meeting of stockholders (the Special Meeting) and submitted one matter to the vote of the stockholders. **Proposal 1.** Due to the absence of a quorum, the named Proxies for the Company's stockholders approved an adjournment of the meeting to allow the polls to remain open until 10:00 a.m. on February 25, 2014 for the proposal to authorize flexibility for the Company, with the approval of its Board of Directors, to sell shares of its common stock during the next 12 months, at a price below its then current net asset value per share, subject to certain limitations as described in the joint proxy statement. The meeting will be reconvened at the offices of Dechert LLP, located at 1095 Avenue of the Americas, New York, New York, on February 25, 2014, at 10:00 a.m.
