Common Stock

Pursuant to the equity distribution agreement, dated June 12, 2013, by and among The Mexico Fund, Inc. (the **Fund**), Impulsora Del Fondo Mexico, S.C., as the Fund's investment adviser, and UBS Securities LLC (the **Manager**), which was filed as an exhibit to the Fund's Registration Statement on Form N-2 (File No. 333-187869) filed with the Securities and Exchange Commission (the **SEC**), as amended, the Fund did not sell any shares of its common stock (the **Shares**), par value \$1.00 per share, through the Manager, acting as sales agent, during the fiscal quarter ended April 30, 2015. Accordingly, the Fund's aggregate net proceeds from sales of its Shares and the commissions to the Manager were \$0.

The Fund's common stock is listed and trades on the New York Stock Exchange, or the NYSE, under the symbol **MXF**. The last reported sale price of the Fund's common stock on the NYSE on June 24, 2015 was \$21.72 per share.

This prospectus supplement should be read in conjunction with, and may not be delivered or utilized without, the prospectus dated February 27, 2015 (the **Base Prospectus**) and the prospectus supplement dated February 27, 2015 (together with the Base Prospectus, the **Prospectus**).
