## EXPLANATORY NOTE

On August 18, 2015, SunCoke Energy, Inc. (the *Company*) filed a Current Report on Form 8-K (the *Original Report*) to report, among other things, the completion of the previously announced acquisition of Raven Energy LLC, a Delaware limited liability company ( *Raven* ) by SunCoke Energy Partners, L.P. (the *Partnership* ), a subsidiary of the Company. Raven Energy LLC owns the Convent Marine Terminal, one of the largest export terminals on the United States Gulf Coast, located in Convent, St. James Parish, Louisiana. As previously disclosed the Convent Marine Terminal is expected to contribute approximately \$20.0 million of Adjusted EBITDA to the Partnership in 2015 and approximately \$60.0 million of Adjusted EBITDA on an annualized basis as a result of the existing contract to provide coal handling and storage services to Foresight Energy, LLC as well as the new contract to provide such services to Murray American Coal, Inc. which became effective as of March 31, 2015. Pursuant to this Amendment No. 1 to the Original Report, the Partnership hereby amends and supplements Item 9.01 of the Original Report to include the required *pro forma* financial information not filed with the Original Report. The Original Report is only amended to the extent specifically provided herein and shall not otherwise be deemed amended or superseded in any other respect.

This Amendment No. 1 to the Original Report, including the exhibits hereto, contains forward-looking statements within the meaning of Section 21E of the Securities Exchange Act of 1934, as amended. Such statements include information regarding the Company's expectations, goals or intentions, including, but not limited to, statements regarding the effects of the Partnership's acquisition of Raven, the valuation of the assets and the purchase price allocation. These forward-looking statements are based on management's current expectations, estimates, forecasts and projections and are subject to risks and uncertainties that could cause actual results and events to differ materially from those stated in the forward-looking statements. These risks and uncertainties include, but are not limited to our ability to successfully integrate the acquired business and realize the anticipated benefits from the Raven acquisition, variations in the final valuation of acquired assets and liabilities, adjustments to the purchase price allocation, and potential impairment of intangible assets and goodwill in the event that changes in circumstances indicate their respective carrying values may not be recoverable.
