Whiting Petroleum Corporation's Special Meeting of Stockholders will be held on November 8, 2017 at the Grand Hyatt Denver Grays Peak Conference Room, located on the 2nd Floor at 1750 Welton Street, Denver, Colorado 80202, at 8:00 a.m., Mountain Time.
