**(b) *Resignation of Derek Harrar as Member of the Board of Directors***

On April 1, 2019, Derek Harrar notified the Board of Directors (the Board) of Brightcove Inc. (the Company) that he intends to resign as a member of the Board, effective as of April 11, 2019 (the Resignation Date). Mr. Harrar's resignation is not the result of any disagreement with the Company on any matter relating to the Company's operations, policies or practices. Effective as of the Resignation Date, (i) the Company agreed to fully accelerate the vesting of Mr. Harrar's unvested stock options and restricted stock units and (ii) Mr. Harrar shall be permitted to exercise any vested stock options he holds as of the Resignation Date until the earlier of (a) the two-year anniversary of the Resignation Date or (b) the expiration date of such stock options.
