Such shares are held jointly and were acquired by Dr. Penneys in connection with the merger of DUSA Pharmaceuticals, Inc. and Sirius Laboratories, Inc. (the "Merger"). Pursuant to the Merger, Dr. Penneys received such 10,663 shares of DUSA common stock and a cash (1) payment in exchange for 101,791 shares of Sirius common stock so held by Dr. Penneys prior to the Merger. Of such 10,663 shares of DUSA common stock, 1,881 shares are being held in escrow for up to two (2) years subject to certain indemnification provisions of the merger agreement. Upon closing of the Merger, Dr. Penneys became a member of the Board of Directors of DUSA.
