The dollar amount being distributed to the Reporting Person was determined by multiplying the number of share equivalents being distributed to the Reporting Person by \$24.11 (the closing price for Hanesbrands Inc. common stock on the valuation date of December 31, 2009).

(3) The balance is determined by dividing the value in the Reporting Person's account following the reported transaction by \$22.88 (the closing price for Hanesbrands Inc. common stock on the transaction date of January 22, 2010).
