- (1) Increase in performance shares granted 8/22/08 based upon performance share payout formula.
- (2) Shares withheld by company to pay tax liability on vesting of performance shares previously awarded.
- (3) Aggregate of 74,023.27 shares listed in Column 5 of Table I includes: (a) 22,300 performance shares previously reported and subject to adjustment and (b) 4,000 restricted shares previously reported and subject to vesting.
- (4) Of the 36,000 shares granted on this 8/26/11 stock option, 12,000 shares are exercisable on 8/26/12, 12,000 shares are exercisable on 8/26/13, and 12,000 shares are exercisable on 8/26/14.

(5) Each performance stock unit represents a contingent right to one share of the Issuer's common stock. Performance stock units are subject to future adjustment; performance period started 7/2/11. The 9,800 performance stock units will vest on 6/27/14. Vested shares are subject to future adjustment and will be delivered to the reporting person within two and one-half months of vesting.
